This statement outlines the Corporate Governance Practices adopted by the Board of Directors for the financial year ended 30 June 2018.

This statement is current as at 18 September 2018 and has been approved by the Board.

This statement explains how Genesis addresses the ASX Corporate Governance Council's Corporate Governance Principles and Recommendations – 3rd Edition (“ASX Principles or Recommendations”).
