**Dear Genesis (GMD) Option Holder,**

**YOUR OPTIONS TO ACQUIRE GMD SHARES AT \$1.00 PER SHARE EXPIRE ON 25 NOVEMBER 2023**

We are writing to you as a registered holder of unquoted options in GMD (exercisable at \$1.00 on or before Saturday **25 November 2023**) (**Options**) to remind you that your Options will expire at 5:00pm (AWST) on Saturday **25 November 2023**. There is no obligation on Option holders to exercise their Options.

Your Option holding may be exercised in **whole or in part** in the manner described below by no later than 5:00pm (AWST) on Saturday **25 November 2023**. Any Options not validly exercised by that time will lapse and all rights under those Options will cease at that time.

The courses of action available to you as a holder of these soon to expire Options are:

- a) Exercise your Options; or
- b) Do nothing (i.e. allow your Options to expire). If you do not exercise your Options they will expire at 5:00pm (AWST) on Saturday **25 November 2023** and your right to subscribe for ordinary shares in GMD at an exercise price of \$1.00 per share will lapse.
